




AHK Coronavirus Measures Protocol (as of August 2020)

The buildings of the AHK academies have been laid out for the coming academic year in accordance with the guidelines of the National Institute for Public Health and the Environment (RIVM) and the central government in order to minimise the risk of coronavirus infection as much as possible. As a result of this, face-to-face teaching on-site is only possible to a limited extent. Teaching will be offered online as much as possible. With these measures, we are doing everything we can to minimise the risk of infection within our buildings as much as possible. In order to achieve that, it is of the utmost importance that employees, teachers and students are alert and comply with the guidelines below.

- Only come to work or school if you do not have any symptoms.
- You should only come to the location, if you do not have any symptoms, as agreed with the supervisor and/or within the timetable drawn up/timeslot designated by the academy.
- Follow all instructions within the buildings.
- It is compulsory to wear a face mask within the communal areas of the buildings, such as entrances, hallways, corridors and sanitary facilities. You can take off your face mask once you are, for example, in a classroom, your workplace or the designated spots in the canteens.
- If you have (mild) coronavirus-like symptoms ¹, please get yourself tested for the coronavirus by the Municipal Health Service (GGD) immediately. This is possible without a referral from the company doctor or GP. <https://www.rijksoverheid.nl/onderwerpen/coronavirus-covid-19/testen/afspraken-maken>
- Stay home until you receive the result of the test. Draw up a list of contacts for the GGD already in the event that the result of the test is positive and the GGD has to inform your contacts.
- In the event of a positive test, you will stay at home, of course, in line with the advice of the GGD.
- You should also stay at home if a housemate has symptoms and the test result is still unknown, or if you have been in (close) contact with someone who has tested positive.
- Cooperate as much as possible with the source and contact tracing conducted by the GGD, so that all colleagues / teachers / classmates concerned can be informed by the GGD about the measures to be taken.
- If you are approached during contact tracing, follow the advice of the GGD immediately.
- In all cases, comply with the quarantine recommended or imposed by the GGD, RIVM or central government and do not come to work or school during that period.
- Students or employees who are returning from a region with code orange or code red travel advice may not come to their work or lessons for 10 days, even if they feel good or have tested negative.
- Students who expect to suffer a study completion delay as a result of the quarantine / isolation imposed by the GGD should contact the study adviser / student counsellor as soon as possible.

NOTE! In the event of a positive test result, the source and contact tracing will be conducted by the GGD. The GGD will inform the specified people, but will not inform the employer or educational institution. If you have tested positive, please inform the academy immediately and in this way help to prevent (part of) the institution from having to be closed by the AHK board or the government, because the proper measures could not be taken in time. ¹ Symptoms that may point to coronavirus infection include a nasal cold, runny nose, sneezing, sore throat, coughing, sudden loss of smell or taste, elevated temperature, fever and shortness of breath.
